### Accident Waiver and Release of Liability

The Race for Cyberspace is a jog-a-thon. Students will be running and/or walking for 30 minutes. I acknowledge that this athletic event carries with it the potential for injury. The risks include, but are not limited to, those caused by terrain, weather, condition of participants, equipment, actions of other people including, but not limited to, participants, volunteers, spectators, event officials, and event monitors, and lack of hydration (although water will be available at all times). These risks are not only inherent to the students, but are also present for volunteers. On behalf of me and my child, I hereby assume all the risks of participating and/or volunteering in this event. I understand that liability may arise from negligence or carelessness on the part of the persons or entities being released, from dangerous or defective equipment or property owned, maintained or controlled by them or because of their possible liability without fault.

I certify that my child is physically fit and has not been advised otherwise by a qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability form will be used by the event holders, sponsors and organizers of the event in which my child may participate.

In consideration of my child's participation in this event, my child and I, on behalf of ourselves, our executors, administrators, heirs, next of kin, successors, and assigns (A) Waive, release and discharge from any and all liability for death, disability, personal injury, property damage, property theft or actions of any kind which may hereafter occur at the Race for Cyberspace, the FOLLOWING ENTITIES OR PERSONS: Tierra Bonita Educational Foundation and Tierra Bonita Elementary School, Twin Peaks Middle School, and each of their directors, officers, employees, volunteers, representatives, and agents, the event holders, and event sponsors; (B) Indemnify and hold harmless the entities or persons mentioned in this paragraph from any and all liabilities or claims made as a result of participation in this event, whether caused by the negligence of releases or otherwise.

On behalf of my child, I hereby consent that he/she receive medical treatment, which may be deemed advisable in the event of injury, accident and/or illness during this event.

I understand that at this event, my child may be photographed. I agree to allow his/her photo, video or film likeness to be used for any legitimate purpose by the event holders, producers, sponsors, organizers and assigns.

This Accident Waiver and Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

- I hereby certify that I have read this document; and I understand its content. The undersigned parent/guardian does hereby represent that he/she is, in fact, acting in such capacity and agrees to save and hold harmless and indemnify each and all of the parties referred to above from all liability, loss, cost, claim or damage whatsoever which may be imposed upon said parties because of any defect in or lack of such capacity to so act and release said parties on behalf of the minor and parents or legal guardian.
